1. Cigarette smoking

1.1. General

The Smoking Restriction in Public Places Law, 1983, states that smoking is prohibited in public places as defined by the law. The law permits smoking in a room or a hall where smoking is explicitly permitted by the person in charge.

1.2. Forbidden places

The following are the areas where smoking is prohibited:

- 1.2.1. Laboratories
- 1.2.2. Study rooms
- 1.2.3. Libraries
- 1.2.4. Lecture halls
- 1.2.5. Corridors
- 1.2.6. Restrooms
- 1.2.7. Restaurants and cafeterias

1.3. Filing a complaint

Anyone who is exposed during his/her stay on the campus to smoking hazards may file a complaint with the FGS Director.

1.4. Handling cigarette butts

It is obligatory to ensure that cigarette butts are put out and deposited safely in ashtrays or dust bins.


2. Drug abuse

2.1. Prohibition of use

Consumption, manufacturing, production, purchase and sale of intoxicants is strictly forbidden on the campus and dormitory grounds.

2.2. Presence on campus under the influence of drugs

It is prohibited to wander around the campus and/or laboratory buildings under the influence of intoxicating drugs.

2.3. **Use of laboratory materials**

No laboratory materials of any kind (e.g., narcotic substances, solvents, reagents, adhesives, etc.) may be used as a substitute or base for intoxicating drugs and/or may be transferred and/or sold to another.

3. **Alcohol abuse**

3.1. **Intoxication**

Alcohol intoxication is strictly prohibited on the campus and in the dormitory grounds.

3.2. **Presence on campus while intoxicated**

It is prohibited to wander around the campus and/or laboratory buildings under the influence of alcohol.

3.3. **Manufacturing and production**

It is forbidden to manufacture and produce intoxicating drinks on the campus and dormitory grounds.

3.4. **Use of laboratory materials**

No laboratory materials of any kind (e.g., narcotic substances, solvents, reagents, adhesives, etc.) may be used as a substitute or base for intoxicating drinks and/or may be transferred and/or sold to another.
